Sealed bids for the construction of the **City of Newport Safe Haven Tsunami Hill Retrofit** for the City of Newport, Lincoln County, Oregon (Owner) will be received by Timothy Gross, PE, Director of Public Work/City Engineer, at 169 SW Coast Highway, Newport OR 97365 until 3:00 pm, July 15th, 2015. Bids received after this time will not be accepted.

Bids will be opened publicly and read aloud immediately following the specified closing time. All interested parties are invited to attend. Subcontractor declarations must be submitted to the above-mentioned City representative no later than 5:00 pm July 15th, 2015. 5:00 pm July 22nd, 2015.

A brief description of the scope of work is provided below:

Improvements shall be completed to the specifications of City, Engineer and FEMA. Complete improvements include the excavation and removal of existing pavement, trees and base materials, grading and paving of a new roadway and access areas to the hill top as well as excavation at the top of the hill. Also included in the Work is the construction of multi-use paths, sidewalks and hiking trail, as well as the installation of conduit for new street lights, and street light bases as shown on Plans.

Other Work shall include the widening of a foot path, wood retaining wall and wooden landing pads as well as the construction of culverts, v-ditches and a CMU-retaining wall.
