To provide virtual public comment during a city meeting, a request must be made to the meeting staff at least 24 hours prior to the start of the meeting. This provision applies only to public comment and presenters outside the area and/or unable to physically attend an in person meeting.

Re: Upcoming Hearing on Custom Creative Work Amendments

A public hearing to consider legislative amendments to create a "custom creative work" use category in commercial zones had been scheduled to occur this evening. Unfortunately, the News-Times failed to publish the legal notice on December 27th, as requested. This means that the hearing has to be postponed since the City is required to provide notice in a newspaper of general circulation at least 5 days and no more than 14 days prior to the date set for public hearing (NMC 14.52.060(F)). The new hearing date will be Monday, January 22nd at 6:00pm. Carol Shenk and Janet Webster, the chief proponents of the amendments, have been informed of the hearing postponement.
