To provide virtual public comment during a city meeting, a request must be made to the meeting staff at least 24 hours prior to the start of the meeting. This provision applies only to public comment and presenters outside the area and/or unable to physically attend an in person meeting.

The agenda may be amended during the meeting to add or delete items, change the order of agenda items, or discuss any other business deemed necessary at the time of the meeting.

The following are my ideas and suggestions for the 2023-2024 BPAC Goals and Objectives. I would like the BPAC to consider, discuss and add more ideas/suggestions prior to approval. City Council is requesting that BPAC approve its '23-24 G&O's by December 30, 2022.

Note: BPAC may run out of bike maps in 2023-2024. Suggest objective "update map before next reprint and/or reprint map." In addition: "acquire funding for map update/reprint."

January – The Vision 2040 Advisory Committee presents annual report to the City Council (1/3/23). City Council goal-setting meeting (1/9/23). City Council approves draft G&Os (1/17/23).

February – The Vision 2040 Advisory Committee provides a report on draft G&Os to the City Council (1/17/23).

March – City Council holds public meeting and adopts G&O's for the upcoming fiscal year, which includes all departmental and advisory committees'' G&O's.

Early April – Upcoming fiscal year's G&O's appear on public website <u>https://www.goals.newpororegon.gov</u> (note these webpages are currently only accessible by a Google search: Strategic Goals Objectives Newport Oregon, then click on "Committees" ).

The following is NMC 2.05.055 which describes the organization and mission of the Bicycle and Pedestrian Advisory Committee. This chapter was enacted by Ordinance No. 2118, effective September 21, 2017.

#### 2.05.055 Bicycle and Pedestrian Advisory Committee

- A. The Bicycle and Pedestrian Advisory Committee shall consist of seven regular members, and up to three alternate members.
- B. Regular and alternate members shall serve three-year terms. All members must be residents, or business owners, of the City of Newport.
- C. An alternate member shall only vote in the absence of a regular member.
- D. The City Manager shall designate a staff member to attend all Bicycle and Pedestrian Advisory Committee meetings. The staff member may participate in discussions and shall act as secretary for the committee, but shall have no vote.
- E. The Bicycle and Pedestrian Advisory Committee may have the responsibility to:
  - 1. Advise the City Council regarding issues relating to bicycle and pedestrian transportation, safety, recreation, and education.
  - 2. Act as a resource to the City Council to provide additional information related to the unique problems associated with non-motorized transportation.
  - 3. Act as a source of current information to the City Council in matters relating to the use of the bicycle or pedestrian routes as a means of transportation in the City of Newport.
  - 4. Review, at the request of the City Council, the goals and objectives of the existing state and city Bicycle and Pedestrian Master Plans, and recommend changes.
  - 5. Advise the City Council of potential funding for bicycle and pedestrian enhancements.
  - 6. Explore and recommend, to the City Council, methods to efficiently and safely move bicyclists and pedestrians through Newport.
  - 7. Support the City Council in creating a greater awareness of non-motorized travel as viable transportation options
  - 8. Recommend to the City Council locations for safe and convenient bicycle parking at all city-owned facilities.
  - 9. At the request of Council, review bicycle and pedestrian involved motor vehicle accidents to identify safety priorities and remedial measures.

## Bylaws of the

## City of Newport

### **Bicycle and Pedestrian Advisory Committee**

#### <u>Article 1</u>

This committee shall be called the Newport Bicycle and Pedestrian Advisory Committee.

#### Article 2: Purpose

The purpose of the committee is to advise the City Council on issues related to active transportation per Newport Municipal Code Chapter 2.05 (Boards and Commissions) Section 2.05.001 (Applicability and Authority), Section 2.05.001 (Board, Committee, and Commission Appointments and Service) and Section 2.05.055 (Bicycle and Pedestrian Advisory Committee).

#### Article 3: Membership

- 1. Committee members are appointed by the City Council.
- 2. At the City Council's option, the Committee may review applications, interview candidates, and make recommendations to the City Council.
- 3. The Committee shall consist of a minimum of seven members and up to three alternate members.
- 4. All terms are two-year terms that end on the  $31^{st}$  of December.
- 5. If a member leaves mid-term, a vacancy is created. When that vacancy is filled the new member shall complete the remainder of that term.
- 6. All members in good standing are given the option of serving a (or another) two-year term.
- 7. Alternate members vote only when quorum (four members) is not met.

### Article 4: Leadership

- 1. A new chairperson and vice-chairperson shall be voted on by the majority of the members on the first meeting of each year.
- 2. The chairperson shall start and end meetings, introduce agenda items, and lead discussion as needed.
- 3. The vice-chairperson shall fulfill the chairperson's role in their absence.

### Article 5: Meetings

- 1. The Committee shall conduct monthly meetings (twelve times a year) unless circumstances do not allow.
- 2. Meetings are usually the second Tuesday of each month, 5:30 p.m. to 7:00 p.m. Members may decide to continue a meeting at or near the meeting's end (7:00 p.m.).
- 3. Members may decide to schedule additional meetings by majority vote.
- 4. Individual members are not obligated to attend more than twelve meetings in a given year. "Attending" a meeting includes meetings that did not reach quorum.
- 5. If membership quorum is not reached by 15 minutes past the scheduled meeting time, the meeting shall be "called" by the Chairperson or, in their absence, an attending member.
- 6. If a meeting is cancelled due to lack of quorum, the attending members may decide whether or not to schedule a make-up meeting and shall determine the day and time.
- 7. At least four members, including alternate members, shall constitute quorum.

## Article 6: Amendments

1. These bylaws may be amended at any time by the Newport City Council. The committee shall make requests to the City Council for necessary and appropriate amendments.

#### Brainstorming: Ways OBPAC Can Help Local BPAC's<sup>1</sup>

These are just a few suggestions; please add your own ideas.

- Regularly provide info to BPAC's on current statewide active transportation issues (new legislation, new ODOT programs, draft documents, etc.)
- Ask ODOT to create a resource page for local BPACs on the ODOT website that includes a library of Oregon active transportation documents (the Bike Bill, *Blueprint for Urban Design,* etc.), tools and links.
- Create a "Best Practices for BPACs" document
- Create a "How to Establish a BPAC in Your Community" document
- Share info between BPAC's (successes, what is working, good ideas, lessons learned)
- Create a discussion forum (list serve) for all BPAC members, ODOT staff and OBPAC members
- Ask ODOT to create a recognition process for local BPAC's
- Connect local BPACs with their local <u>Area Commission on Transportation</u>'s active transportation representative.
- Create a communication link between BPACs and OBPAC regarding state-designated regional bike routes that pass through BPACs' jurisdictions.
