TASK ORDER NO. 12

Professional Services Agreement for Civil Engineering, Geotechnical, Architecture, and Other Related Professional Services

On Demand Emergency WTP Services

This TASK ORDER NO. 12 to the Professional Services Agreement dated May 5, 2017, hereinafter called Agreement, between the City of Newport, (CITY), and HDR Engineering, Inc.. (ENGINEER)

A. SCOPE OF SERVICES

CITY agrees to utilize the services of ENGINEER and ENGINEER agrees to perform on call emergency water treatment plant (WTP) engineering support services as requested by CITY, services include:

- Troubleshoot the existing WTP treatment issues
- Provide assistance to the City over the phone and in person, if necessary
- Design temporary treatment unit connections and hydraulic requirements
- Review and analyze water quality data
- Participate in conference calls with City and membrane manufacturer
- Provide support for the temporary treatment unit. HDR cannot operate the unit under Oregon licensing requirements.
- Tasks as requested by the City related to this task order

B. CITY'S RESPONSIBILITIES

CITY shall provide to the ENGINEER:

1. Requested data and timely review of submitted documents, as appropriate.
2. City will operate the temporary treatment units with an Oregon certified operator.

C. COMPENSATION

1. CITY shall pay ENGINEER according to the negotiated rates as provided in Section 3 of the Agreement and Exhibit A thereto.
2. Services provided under this Task Order No. 12 shall be provided on a time and material basis without a not to exceed amount. Work will be performed as authorized via email and billed monthly according to Item C-1 above.

D. MISCELLANEOUS

All terms and conditions of the Agreement apply to this Task Order No. 12 as though fully set forth therein. In the event of a conflict between previous task orders and the Agreement, the terms of this Task Order No. 12 shall apply.

The parties do mutually agree to all mutual covenants and agreements contained within this Task Order No. 12.


