#### A RESOLUTION OF THE CITY OF NEWPORT ADOPTING AN EMERGENCY MEDICAL SERVICE RESPONSE MATRIX

WHEREAS, in January of 2017, a presentation was made to the City Council regarding responses to false alarms; and

WHEREAS, at the January 2017 meeting, the City Council inquired as to why the Fire Department were responding to so many medical calls; and

WHEREAS, in September of 2018, the Fire Chief updated Council regarding the medical responses made by the Fire Department; and

WHEREAS, in response to Council discussion, an emergency medical service response matrix was developed by the Fire Department, and discussed and approved by the City Council.

THE CITY OF NEWPORT RESOLVES AS FOLLOWS:

<u>Section 1</u>. The City Council of the City of Newport hereby adopts the emergency medical service response matrix as attached to this Resolution as Attachment A.

<u>Section 2</u>. This Resolution will become effective on July 1, 2019.

# **Priority Definitions**

Priority 1	Critical symptoms (Altered LOC, difficulty breathing, unconscious, etc.)
Priority 2	non-critical symptoms present
Priority 3	non-critical symptoms generally at a health care facility or clinic
Priority 4	generally transport unlikely (ie: public safety Personnel on scene, obvious DOA or very minor or no injury)
